- iv. Experience Certificate(s), if experience is claimed.
- v. Original BED Entrance Examination Admit Card.
- vi. Original Anti-ragging Affidavits in the prescribed formats duly **Notarized** and signed by Parents and Applicant separately, as given in the Prospectus.
- vii. Category Certificate from Competent Authority of the Govt. (SC/ST/OBC (Non Creamy Layer)/PWD/WW/KM) for claiming Seat under respective Category in accordance with the University (IGNOU) Provisions notified.
- viii. Original Certificate from the recognized Secondary/Senior Secondary Schools to provide facilities for Practical Work including Internship, as per the format enclosed.
- ix. OBC-Non Creamy Certificate for claiming OBC (Non-Creamy) Seat **Should not be older than 3 years**.
- x. Income Certificate from Competent Authority of the Govt. or Tehsildar / SDO (in case of OBC-Non-Creamy layer)
- xi. The Candidate must meet all the eligibility criteria as per Student Hand Book & Prospectus (B.Ed January 2016 programme).
- xii. Recognition / Affiliation Certificate issued by CBSE/ICSE/WBBSE/WBCHES to the School indicating the Registration Number of your School. If you have worked in more than one School, you must submit attested copies of all the Recognition/Affiliation Certificates of all schools you have worked.
